Clarity of communication	4	Very unfussy, spare, abstract - as Balanchine would have wanted
Quality of production – production's success in relation to stated aims i.e., in the programme or other printed material)	3	Such a pleasant surprise that a company so poorly presented in the printed programme could come up with such wonders on the stage.

Choreography - originality, use of space, number and use of dancers, length of piece, etc	5	I do not think a comment here is necessary....
Performers - technical standard, performance skills, and ability to communicate	5	Quality and commitment all through the company. Someone has done a lot of work to raise standards so fast
Sound – appropriateness and effect of sound or music (whole/part, live/ recorded) to the production.	5	I would hate to comment on the obvious – that Stravinsky and Balanchine were rather good together. Scottish Chamber Orchestra sounded in really good form.
Design – costume, set, lighting	5	Immaculate
Technical standards – technical presentation of the production (e.g. lighting and sound cues, etc)	5	Top marks. Could scarcely find a glitch....
Audience – appropriateness of the production for the audience, estimate the size and reaction	4	Had the feel of a big occasion and a turn-around for S Ballet. They can build a committed audience from this if they do not have one already...

Access and provision for disabled people	4	I saw plenty of wheelchair spaces and for an unreformed building, quite disabled friendly.
Timing of the event	3	Normal
